Step 6: Go shopping somewhere else

Materials: patience, and lots of it

Instruction: Repeat #5. Remember, be positive: finding two more products that weren't in the last store is better than finding none!

Step 7: Edit your list; adjust your recipes

Material: big eraser

Instructions: Delete the following products, Ankang doesn't have them, anywhere: pasta, Italian spices, Italian herbs, tomato sauce, black pepper, baking soda, vanilla, milk, cheese, cream, butter (despite attendants trying to convince you sweetened condensed milk is the same thing), and chocolate. Readjust your menu. Hope that recipes can still be slightly palatable even if half the ingredients are missing.

Step 8: One more supermarket

Materials: your pointer finger

Instructions: This time you're alone. (It turns out your English-speaking translator actually has a life.) Point at

the products on your list & use your limited Chinese to say, “This one?” When you can't distinguish the meat, in Chinese, try drawing a picture of a cow & a pig. Never mind your poor artistic skills. Don't get exasperated when they think your cow is a chicken. Try mooing. Don't be embarrassed as a crowd of workers flock around you, eager to play the guessing game. Try oinking. That doesn't work either? Give up. Just point to a meat, and you think it is.

Instructions: Point to “butter” in Chinese characters (you're putting a lot of trust in Google's translator). Baker retreats to his back room; returns with giant plastic bag filled with a mountainous glob of yellow—something. It could be butter. At this point, you'll take anything. Instructions: Review your list: spaghetti (Chinese noodles); homemade sauce (tomatoes, carrots, garlic, oil, chopped meat— together, these can
